TECHNICAL SPECIFICATIONS AND OTHER IMPORTANT REQUIREMENTS Instruction to bidders

1. Service Provider Obligations:

- The Service Provider shall be responsible for providing the 20 Mbps leased line internet connectivity at CSIR-CIMAP based on 1:1 ratio, at all the time (24x7x365) throughout the contract period.
- The Service Provider shall be responsible for commissioning and configuring of hardware and uplink of connectivity.
- Liaisoning (if required) with any other agency/organization(s) for providing point to point connectivity between ISP node and Institute, shall be the sole responsibility of the Service Provider.
- The Service Provider should provide all necessary equipment for connectivity along with details of make and model of equipment, if any.
- The Service Provider shall be responsible for provisioning end to end solution
- The Service Provider should provide the tool to monitor the bandwidth / network performance without additional cost.
- The Service Provider would ensure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks.

2. Service Level Guarantee:

- Service Provider should provide minimum subnet of 08 Public IP addresses at CSIR-CIMAP, including Reverse Lookups configured at these IP's.
- Packet Losses: Less than 1 % (Average over 1000 ping) at any given point of time to any part of Country / ISP Internet gateway.
- Latency: Less than 100ms from the Institute to ISP's tier one peering point. Latency can be randomly checked on daily basis. In case of non-adherence latency limit, the link will be considered as down with effect from time of detection until the same is restored.
- Network Availability: More than 99.50 % uptime per month will be considered as satisfactory services.
- Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the Institute.
- Uptime Calculation (in Percentage): Uptime shall be calculated as (Actual Uptime Hours / Total Uptime Hours) x 100. Payment will be calculated on monthly basis by considering the performance and efficiency in particular month.
- The Firm should ensure that minimum downtime should be maintained in all working days and office working hours of institute. A calendar will be provided for the information of all working days of institute.
- The response time for attending the faults will be 1 hour after being reported to the ISP. The ISP will rectify the faults within 3 hours failing which; the vendor will arrange temporary replacements for connectivity of the institute.

Note: Firm will be penalized in case of failure to provide satisfactory services and penalty will be imposed on basis of Percentage or Service Days Credit. Institute reserve the rights that both penalties may be charge to the vendor in case of unsatisfactory services.

Calculation of Actual Uptime % = (Actual Uptime Hours / Total Uptime hours) X 100

Definition: Total Uptime hours = No of days in month X 24 Actual Uptime Hours = Total Uptime hours – Downtime in hours in a month

Example: In the Month having total days is 31 and total down time in the same month in hours was 7

hours. In such case the Actual Uptime can be calculated as follows:

Total Uptime hours = 31 X 24 = 744 Actual Uptime Hours = 744 – 7 = 737

Actual Uptime % = (737/744) X 100 = 99 %

- Downtime due to the following situations will not be considered for the purpose of penalty:
 - Link down due to power failure or any critical situation at the institute.
 - Due to schedule maintenance by the Service Provider, with prior approval of Institute.

5. Public IP Range:

The service provider must provide public IP Range of 8 IP addresses of /29 prefix, along with the leased line connection.

6. Local Conditions:

It shall be the responsibility on each ISP to fully inform / acquaint / familiarized itself with local conditions and factors, which may have any effect on the execution of services to be rendered under the contract. All tenderer(s) intending to bid may visit and make themselves thoroughly acquainted with the local site conditions.

7. Installation & Commissioning:

Project should be completed within 4 weeks from the date of issue of the work order at CSIR-CIMAP. All aspects of safe delivery, installation, commissioning and uplink of the connectivity shall be the sole responsibility of the Service Provider. If the Service Provider fails to uplink the connectivity by the specified date, then the penalty at the rate of 1% per week of the total order value subject to maximum of 10% of total order value will be deducted.

The Director, CIMAP has reserves the right to scrutinize credentials of all tenders and to arrive at a conclusion to its satisfaction regarding the suitability of the party based on such examination/enquiry as deemed necessary. Issuing of tender form will not as such be accepted as proof of eligibility for the contract. A committee will first open envelope `A' in respect of Tenderers and after the committee has satisfied itself that All documents/information required have been furnished and the Tenderer is found suitable and competent for performing the job, committee will open the envelope `B'. NOW THEREFORE BY THESE ARTICLES AND ON THE PREMISES mentioned above, the parties have agreed to as under:

A. GENERAL CONDITIONS

- a) Service Provider should provide minimum subnet of 08 Public IP addresses at CSIR-CIMAP, including Reverse Lookups configured at these IP's.
- b) Packet Losses: Less than 1 % (Average over 1000 ping) at any given point of time to any part of Country / ISP Internet gateway.
- c) Latency: Less than 100ms from the Institute to ISP's tier one peering point. Latency can be randomly checked on daily basis. In case of non-adherence latency limit, the link will be considered as down with effect from time of detection until the same is restored.
- d) Network Availability: More than 99.50 % uptime per month will be considered as satisfactory services.
- e) Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the Institute.
- f) Uptime Calculation (in Percentage): Uptime shall be calculated as (Actual Uptime Hours / Total Uptime Hours) x 100. Payment will be calculated on monthly basis by considering the performance and efficiency in particular month.
- g) The Firm should ensure that minimum downtime should be maintained in all working days and office working hours of institute. A calendar will be provided for the information of all working days of institute.
- h) The response time for attending the faults will be 1 hour after being reported to the ISP. The ISP will rectify the faults within 3 hours failing which; the vendor will arrange temporary replacements for connectivity of the institute.

B.SERVICE PROVIDER OBLIGATIONS

- a)The Service Provider shall be responsible for providing the 20 Mbps leased line internet connectivity at CSIR-CIMAP based on 1:1 ratio, at all the time (24x7x365) throughout the contract period.
- b) The Service Provider shall be responsible for commissioning and configuring of hardware and uplink of connectivity.
- c)Liaisoning (if required) with any other agency/organization(s) for providing point to point connectivity between ISP node and Institute, shall be the sole responsibility of the Service Provider.
- d) The Service Provider should provide all necessary equipment for connectivity along with details of make and model of equipment, if any.
- e)The Service Provider shall be responsible for provisioning end to end solution
- f) The Service Provider should provide the tool to monitor the bandwidth / network performance without additional cost.
- g)The Service Provider would ensure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks.
- h) The Service Provider will do preventive maintenance once a quarter for upkeepof the systems running. The schedule will have to be adhered to strictly

1. Downtime penalty in % of monthly payment:

Note: Firm will be penalized in case of failure to provide satisfactory services and penalty will be imposed on basis of Percentage or Service Days Credit. Institute reserve the rights that both penalties may be charge to the vendor in case of unsatisfactory services.

Calculation of Actual Uptime % = (Actual Uptime Hours / Total Uptime hours) X 100

Definition: Total Uptime hours = No of days in month X 24 Actual Uptime Hours = Total Uptime hours – Downtime in hours in a month

Example: In the Month having total days is 31 and total down time in the same month in hours was 7 hours. In such case the Actual Uptime can be calculated as follows:

Total Uptime hours = 31 X 24 = 744 Actual Uptime Hours = 744 - 7 = 737 Actual Uptime % = (737/744) X 100 = 99 %

- 2. Downtime due to the following situations will not be considered for the purpose of penalty:
 - a) Link down due to power failure or any critical situation at the institute.
 - b) Due to schedule maintenance by the Service Provider, with prior approval of Institute.
- **3.** The security money so deposited shall be liable to be forfeited or appropriated in the event of unsatisfactory performance of the firm and/or loss/damage if any, sustained by the Institute on account of the failure or negligence of the services provided by him or in the event of breach of the agreement by the firm

F. COMMENCEMENT AND TERMINATION

- 2. That this agreement may be terminated on any of the following contingencies:
 - a. On the expiry of the contract period as stated above.
 - b. By giving one month's notice by CSIR on account of :
 - I. For committing breach by the firm of any of the terms and conditions of this agreement.

If CIMAP considers that the performance of the successful bidder is unsatisfactory or not up to the expected standard, CIMAP shall notify the successful bidder in writing and specify in detail the causes of dissatisfaction. CIMAP shall have the option to forthwith terminate the contract, if successful bidder fails to comply with the requisitions contained in the said written notice issued by CIMAP within ten days of the receipt thereof.

- II. On assigning the contract or any part thereof to any sub-contractor by the firm without written permission of the Lab./Instt.
- c. On Bidder being declared insolvent by competent Court of Law.

During the notice period for termination of the contract. In the situation contemplated above, the Contractor shall keep on discharging his duties as before till the expiry of notice period.

G. ARBITRATION

- 1. In the event of any question, dispute/difference arising out of the agreement shall be referred to Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi.
- 2. The award of the arbitrator shall be final and binding on the parties. In the event of such arbitrator to whom the matter is originally referred is being transferred or vacating his office or resigning or refusing to work or neglecting his work or being unable to act for any reason whatsoever, the Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi shall appoint another person to act as arbitrator in place of the out-going arbitrator in accordance with the terms of this agreement and the person so appointed shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.
- 3. The Arbitrator may give interim award (s) and/or directions, as may be required.
- 4. Subject to the aforesaid provisions, the Arbitration & Conciliation Act, 1996 and the rules made hereunder and any modification thereof from time to time being in force shall be deemed to apply to the arbitration proceedings under this clause
